

Memorandum of Understanding
(Hereinafter referred to as “MOU”)
by and between

SR University, Warangal, India
&
Malla Reddy College of Engineering
Maisammaguda, Dhulapally, Secunderabad, Hyderabad, Telangana, India-500100

This Memorandum of Understanding (MoU) is entered into on [29 / 01 / 2026] between **SR University (SRU)**, located at Ananthasagar, Hasanparthy, Warangal – 506371, Telangana, India, and **Malla Reddy College of Engineering (MRCE)**, located at Maisammaguda, Dhulapally, Kompally, Secunderabad, Hyderabad, Telangana, India – 500100. SR University and Malla Reddy College of Engineering are hereinafter individually referred to as a “**Party**” and collectively referred to as “**the Parties.**”

1. Purpose

The purpose of this MoU is to establish a collaborative partnership between the two educational institutions to promote academic, research, and cultural exchanges, and to enhance mutual cooperation in various areas of common interest.

2. Scope of Cooperation

The Parties agree to collaborate in the following areas, but not limited to:

a. Faculty and Staff Exchange

Exchange and collaboration of faculty members and staff for teaching, joint research, academic mentoring, training programs, and professional development initiatives.

b. Student Mobility and Engagement

Facilitation of student exchange programs, progression pathways, short-term academic programs, internships, industrial training, project work, and research opportunities.

c. Joint Research and Publications

Promoting collaborative research projects, sharing research findings, and jointly publishing scholarly articles and academic papers.

d. Research Scholar Allotment

To encourage collaborative research activities, faculty members of **Malla Reddy College of Engineering** may be recognized as research supervisors and may be allotted full-time or part-time **Ph.D. scholars, as per SRU norms.**

e. Curriculum Development

Sharing expertise and best practices to enhance the quality of educational programs, including joint course development, curriculum design, and pedagogical innovations.

f. Cultural and Academic Events

Organizing joint seminars, workshops, conferences, symposiums, and cultural activities to foster academic discourse and cross-cultural understanding.

g. Resource Sharing

Collaborating on the sharing of library resources, databases, research facilities, laboratories, and other educational materials, subject to mutual agreement.

h. Other Areas of Cooperation

Exploring additional areas of cooperation based on mutual interest and written consent of both Parties.

3. Responsibilities of the Parties

- a.** Each institution shall appoint a designated representative responsible for coordinating and facilitating the implementation of this MoU.
- b.** A Joint Coordination Committee comprising representatives from both institutions shall be constituted to oversee, monitor, and evaluate collaborative activities.
- c.** Specific details, timelines, financial implications, and responsibilities for each collaborative activity shall be mutually decided and documented through separate agreements, addenda, or project-specific protocols.
- d.** The Parties shall comply with all applicable laws, rules, regulations, and institutional policies while implementing activities under this MoU.
- e.** Both institutions shall ensure confidentiality of shared information or materials unless otherwise agreed in writing.

f. This MoU does not imply any binding financial commitments, nor does it guarantee a minimum number of exchanges of faculty, students, research scholars, or resources. All financial arrangements shall be negotiated separately on a case-to-case basis through written Project Agreements/Addenda, subject to availability of funds.

4. Funding and Resources

- a. Each Party shall bear its own costs incurred in the implementation of this MoU unless otherwise agreed in writing for specific activities.
- b. The Parties may jointly seek external funding, sponsorships, or grants from government agencies, industry, or other funding bodies to support collaborative initiatives.

5. Duration and Termination

- a. This MoU shall remain in force for a period of **five (5) years** from the date of signing, unless terminated earlier by mutual written consent or due to unforeseen circumstances.
- b. Either Party may terminate this MoU by providing **one (1) month's prior written notice** to the other Party.

6. Confidentiality

- a. SR University and Malla Reddy College of Engineering agree to hold in confidence all information or data designated as confidential that is obtained from the other Party or generated during the execution of this MoU. Such information shall not be disclosed to any third party without prior written consent.
- b. The confidentiality obligation shall not apply to information that was already in the possession of either Party prior to entering into this MoU, independently developed, or available in the public domain.

7. Intellectual Property Rights (IPR)

Intellectual Property Rights arising from joint research or collaborative activities under this MoU shall be determined on a case-by-case basis and shall be governed by the respective IPR policies of SR University and Malla Reddy College of Engineering.

8. Amendments

Any amendment, modification, or extension of this MoU shall be made in writing and shall become effective only upon mutual agreement and signature by authorized representatives of both Parties.

9. General Provisions

This MoU is a statement of intent and does not create any legal or financial obligations between the Parties, except as expressly agreed through separate written agreements.
