M.1.1 This MEMORANDUM OF UNDERSTANDING (MoU) is made and entered into force on this day 05-11- 2024. between Malla Reddy Institute of Dental Sciences (**MRIDS**) under Chandramma Educational Society (**CES**), situated at Quthbullapur, Suraram- 500055, Hyderabad, Telangana State (hereafter referred as "**MRIDS**") which expression shall where the context so admits mean and include its successors, representatives and permitted assigns of the First part,

And

M.1.2 Malla Reddy College of Engineering, located at the Maisammaguda, Dhulapally, post via Kompally, Secunderabad, Telangana - mentioned above) herein after referred to as "**MRCE**" which expression shall, where the context so admits, mean and include its successors, representatives and permitted assigns of the other part.

M.2. Preamble:

1M.2.1. **MRIDS** is a Dental college and hospital with "Dental care practice" and desire to promote academics, research and innovation activities among the students, interns and faculty of the institute.

M.2.2 **MRCE** is the Center of Excellence for producing professionals who shall be the leaders in technology innovation, entrepreneurship, management and in turn contribute for advancement of society and human kind.

M.3.1 Both parties agree to contribute relevant resources and strength pursuant to its commitment and in furtherance of objectives of this MoU. The two Institutes after considering their objectives and strengths have agreed. This MoU is to bring awareness on oral and dental care which will build health among the community. Through this MOU, **Malla Reddy Institute of Dental Sciences** intends to set up and support a **Dental and Oral care**, in the MRCE college premises

Expectations from the MRCE :

- To assign a faculty who will be responsible to oversee and run the Dental camp and also have a group of dedicated core student leaders.
- Coordinate with **MRIDS** to execute all the monthly events.
- Work with **MRIDS** in conducting relevant activities under the Dental and Oral Care.
- Ensure participation of all students in the above mentioned said events and connecting resources and infrastructure.

Expectations from MRIDS:

- Design and provide execution plan for all Dental and Oral Care activities conducted monthly in the college.
- Coordinate with the college for conducting awareness programs for students and staff on oral and dental care.
- Certify and encourage student leaders and faculty members involved in the conducting of various activities.

M.3.2. Specific terms, conditions and procedural aspects of collaboration including financial obligations of either party shall be finalized on mutual discussion in respect of each specific project under this MoU separately.

M.4 Duration

This Memorandum of Understanding shall be valid for a period of **five years** from the date of signing of the same and thereafter can be renewed for further periods subject to such other terms and conditions as may be mutually agreed upon.

M.5 Termination

Notwithstanding clause 7, either of the participating parties may terminate this MoU by giving three months notice in writing to the other party. Either of the parties shall honor within a mutually agreed period, the outstanding commitments, if any, as on the date of termination.

M.6 Notices

M.6.1 All notices and other communications required to be served on **MRIDS** under the terms and this MoU, shall be considered to be duly served; if the same is delivered at or posted by email or registered mail to the "**Concerned Department, Malla Reddy Institute of Dental Sciences, Quthbullapur, Suraram, Hyderabad, Telangana State, India.** Similarly, any notice to be given to the **Malla Reddy College of engineering** shall be considered as duly served, if the same is delivered at or posted by email or registered mail to the "**Concerned Department, Malla Reddy College of engineering, Maisammaguda, Dhulapally, post via Kompally, Secunderabad, Telangana**

M.10 Arbitration

10.1 In the event of any dispute or difference between the parties hereto, such differences shall be resolved amicably by mutual consultation. Where it could not be resolved so, then it shall be referred to arbitration of two Arbitrators, one to be appointed by each party to the dispute and in case of difference of opinion between the said two Arbitrators, then to an umpire appointed by the said two Arbitrators. The decision of the said Arbitrators or Umpire as the case may be shall be final and binding on both parties. The venue of arbitration shall be at such place as may be fixed by the arbitrators or umpire and the arbitration proceeding shall be as provided under the Arbitration and Conciliation Act, 1996.

M.11 Jurisdiction

All legal disputes shall be subjected to the jurisdiction of the courts at Hyderabad, Telangana state only.

M.12 Modification

No modification to this MoU shall be binding unless made in writing and signed by both parties.


M.13 Force Majeure

Any of the parties hereto shall not be released from its obligations for any reason except for force majeure such as war, strike, fire, acts of God or other causes beyond control of the parties.


