## MEMORANDUM OF UNDERSTANDING (MOU)

### Purpose of the MOU

This Memorandum of Understanding (MOU) is entered into on this 30th September 2024, between Malla Reddy College of Engineering, an esteemed academic institution, and TcollegeDayz Private Limited, an Overseas Education Consulting firm, for the purpose of formalising a collaborative partnership aimed at promoting international education and providing seamless counseling services to students aspiring to study abroad.

### Scope of the Collaboration

The objective of this MOU is to establish a framework for cooperation and collaboration between the parties. The partnership will focus on the following areas:

- 1. Promotion of Overseas Education Opportunities:**  
TcollegeDayz Private Limited will assist Malla Reddy College of Engineering in promoting study abroad opportunities among students through seminars, webinars, and direct counseling sessions and allow TcollegeDayz Private Limited related events at campus.
- 2. Student Counseling Services:**  
TcollegeDayz Private Limited will provide expert guidance and consulting services to students of Malla Reddy College of Engineering, assisting them in identifying and applying to international universities that align with their academic and career aspirations.
- 3. Application Assistance and Visa Processing:**  
TcollegeDayz Private Limited will support students with the application process, including university shortlisting, documentation, and visa guidance.

#### **4. Educational Seminars and Webinars:**

Both parties will organise joint events, including workshops, seminars, and webinars, to educate students and staff about overseas education trends, scholarship opportunities, and immigration processes.

#### **5. Collaborative Marketing:**

Both parties agree to work together on marketing efforts such as social media campaigns, print advertisements, and digital platforms to promote the collaboration and the services offered under this MOU.

### **Service Charges**

- TcollegeDayz Private Limited will charge a **service fee of 5000 INR plus GST** for processing overseas education applications.
- However, for students applying to universities in the **UK, Canada, or Australia, no processing charges** will be applied.

### **Roles and Responsibilities**

- **Malla Reddy College of Engineering**
  - Provide access to students interested in studying abroad.
  - Facilitate student participation in events organized in collaboration with TcollegeDayz Private Limited.
  - Allow TcollegeDayz Private Limited to promote its services on-campus, including information desks and promotional materials.
- **TcollegeDayz Private Limited**
  - Offer professional consulting services related to overseas education to students of Malla Reddy College of Engineering.
  - Provide comprehensive application, scholarship, and visa processing support.
  - Organize promotional events and webinars tailored to Malla Reddy College of Engineering's student needs.

### **Duration of the Agreement**

This MOU will come into effect from the date of signing and will remain valid for a period of one (1) year, unless terminated earlier by either party with thirty (30) days' written notice. The MOU may be renewed upon mutual agreement.

### **Confidentiality**

Both parties agree to maintain the confidentiality of student data and any sensitive information shared during the course of this partnership.

### **Amendments**

Any amendments or changes to this MOU must be made in writing and signed by both parties.

## Termination

Either party may terminate this MOU by providing 30 days' written notice to the other party. In the event of termination, all services and activities will cease, and both parties will settle any outstanding obligations.

## Dispute Resolution

In the event of any dispute arising out of this MOU, both parties agree to resolve the matter amicably through mutual discussion. If the issue remains unresolved, it will be referred to a mutually agreed arbitrator whose decision shall be final and binding.
