As per the Regulations notified by the Council vide F.No. 37-3/Legal/2004 dated 28th November 2005 and norms, standards, procedures and conditions prescribed by the Council from time to time the compliance report / proposal for increase / variation in intake / introduction of additional courses submitted by C M ENGINEERING COLLEGE SY, NO. 518, 519, 521 & 532 MYSAMMAGUDA, DHULAPALLI (POST), HAKIMPET, SECUNDERABAD, ANDHRA PRADESH. has been processed through an Appraisal Committee / Hearing Committee and I am directed to convey the approval of the Council for the courses and intake as per the details given below:

The above approval is subject to rectification of the following observations / deficiencies / specific conditions by 31st August 2006.

The additional facilities I.e. faculty, Built-up space, library, computers, laboratories etc. as per AICTE norms for the additional course / increase in intake sanctioned above should be created as per the projections shown in the Detailed Project Report and the same may be submitted alongwith the compliance report.

- Faculty members are inexperienced; Sr. level faculty in cadre ratio as per AICTE norms should be appointed. Faculty members are being paid fixed salary; AICTE Pay scales should be implemented for all the faculty and staff. Faculty in the Humanities & Sc. should be appointed in the ratio of 1:15 for the incoming batch of students. *

Others:

- Computers, books, titles and journals to be provided as per AICTE norms. Internet facilities need improvement. 4
- Placement cell needs improvement.
- Modern teaching aids are not available; technical staff should be increased.

- Library should be computersied.

 Canteen/sports facilities should be improved.

 Labs should be reorganised with built up area as per AICTE norms.
- The institution should submit a report regarding the availability of land areas of all the colleges in the carripus.
- A certificate from structural engineer is required stating that the structure is earthquake resistant. The deficiencies communicated in the last approval letter are not fully complied with.

Note: 1. The specific deficiencies for not granting increase / variation in intake / additional courses to the institution are mentioned below:

Increase in intake in CSE and ECE has not been granted as there are not Professors and Asstt. Professors available in the relevant

The institution is required to submit two copies of the Compliance Report, indicating the rectification of deficiencies along with mandatory disclosure and details of faculty recruited for each course in the prescribed format (available at AICTE Website 2006-07.

The Compliance Report must be accompanied with a processing fee of Rs. 40,000/- in the form of demand draft in the favour of Member Secretary, AICTE, payable at New Delhi. In the absence of processing fee the Compliance Report will not be entertained. Following the Compliance report, the Council would verify the status in respect of rectification of deficiencies through surprise

The above approval if granted after rectification of deficiencies would be subject to the fulfillment of the following general conditions:

- 1 That the management shall provide adequate funds for development of land and for providing related infrastructural, instructional and other facilities as per norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
- (a) That the admission shall be made only after adequate infrastructure and all other facilities are provided as per norms and guidelines of the AICTE.
 - (b) That the admissions shall be made in accordance with the regulations notified by the Council from time to time.
 - (c) That the curriculum of the course, the procedure for evaluation/ assessment of students shall be in accordance with the norms prescribed by the AICTE.
 - (d) That the Institution shall not allow closure of the Institution or discontinuation of the course(s) or start any new course(s) or alter intake capacity of seats without the prior approval of the Council.
 - (e) That no excess admission shall be made by the institution over and above the approved intake under any circumstances. In case any excess admission is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the institution
 - (f) That the Institutions shall not have any collaborative arrangements with any Indian and/ or Foreign Universities for conduct of technical courses other than those approved by AICTE without obtaining prior approval from AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution
 - (g) That the Institution shall not conduct any course(s) in the field of technical education in the same premises/ campus and / or in the name of the Institution without prior permission/ approval of AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be Initiated against the Institution
 - (h) The Institution shall not conduct any non-technical course(s) in the same premises/ campus under any circumstances. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution
- That the institution shall operate only from the approved location, and that the institution shall not open any off campus study centers/ extension centers directly or in collaboration with any other institution/ university/ organization for the purpose of imparting technical education without obtaining prior approval from the AICTE.
- 4 That the tuition and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Council from time to time. No capitation fee shall be charged from the students/ guardians of students in any form.
- 5 That the accounts of the Institution shall be audited annually by a certified Chartered Accountant and shall be open for inspection by the Council or any body or persons authorized by
- 6 the Director/ Principal and the teaching and other staff shall be selected according to procedures, qualifications and experience prescribed by the Council from time to time and pay scales are as per the norms prescribed by the Council from time to time.
- 7 .(a) That the institution shall furnish requisite returns and reports as desired by AICTE in order to ensure proper maintenance of administrative and academic standards.
 - (b) That the technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institution and courses/ programmes being conducted and details of infrastructural facilities including faculty etc. in the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education on cost basis. The mandatory disclosure information shall be put on the institution Website. The information shall be revised every year with updated information about all aspects of the institution.

- That it shall be mandatory for the technical institution to maintain a Website providing the prescribed (c) information. The Website information must be continuously updated as and when changes take place.
- That a compliance report in the prescribed format along with mandatory disclosures on fulfillment of the above conditions, shall be submitted each year by the Institution within the time limit prescribed by the Council from time to time I.e. 31st August 2006 for the current year. (d)
- That if Technical institution fails to disclose the information or suppress and/ or misrepresent the information appropriate action could be initiated including withdrawal of AICTE approval. (6)
- That all the laboratories, workshops etc. shall be equipped as per-the syllabl of the concerned affiliated University and shall be in-operational condition before making admissions.
- That a library shall be established with adequate number of titles, books, journals (both Indian & Foreign) etc as per 9
- 10 That a computer center with adequate number of terminals, Printers etc. shall be established as per AICTE norms.
- AICTE may carry out random inspections round the year for verifying the status of the Institutions to ensure maintenance
- That the AICTE may also conduct inspections with of without notifying the dates to verify specific complaints of mis-1 10 0000 --
- That the Institution by virtue of the approval given by Council shall not automatically become claimant to any grant-in-aid
- 14. That the Management shall strictly follow further conditions as may be specified by the Council from time to time.
- In the event of non-compliance by the C M ENGINEERING COLLEGE SY. NO. 518, 519, 521 & 532 MYSAMMAGUDA, DHULAPALLI (POST), HAKIMPET, SECUNDERABAD, ANDHRA PRADESH. With regard to guidelines, norms and recognitions prescribed from time to time the Council shall be free to take measures for withdrawal of its approval or be that of C M ENGINEERING COLLEGE SY. NO. 518, 519, 521 & 532 MYSAMMAGUDA, DHULAPALLI (POST), HAKIMPET, SECUNDERABAD, ANDHRA PRADESH.
