The user ID and Password is same as that of PG Project Panels uploading service. The name of the document shall be the '*student hall ticket number-title of the thesis.pdf*.'

The thesis will be accepted for submission in plagiarism check, the similarity index should be less than **30%**. If the similarity index is more than the required percentage, the student shall be advised to modify accordingly and re-submit the soft copy of the thesis after one month. The maximum number of re-submissions of thesis after plagiarism check is limited to **TWO** (total three attempts). After three unsuccessful attempts the candidate has to register for the Project work for **one more semester**.
